By signing below I release, discharge and agree to defend, indemnify and hold harmless the Town of Sharon, the School Committee, School Department and all their past, present and future officers, agents, servants, employees and attorneys (collectively "Town of Sharon") from any and all liability, whatsoever for any and all damages, loss or injuries (including death), sustained by the Student/Participant or his/her property, or both, including but not limited to any third-party claims, demands, causes of action, judgment, damages, expenses, and costs, including attorney's fees and costs of suit, which arise out of, occur during, or are in any way connected to the Student/Participant's travel to and from the Event/Activity (and related Site).

I represent and agree that I will not transport any other Sharon students in connection with the Event/Activity listed above (and related Site), unless such students are also members of my family and/or siblings of Student/Participant.

I agree that if any portion this document is held to be invalid, the balance hereof shall, notwithstanding, continue in full legal force and effect.
